### Insurance FAQ's

**Q: What Does the Policy Cover?**

A: The StorageShield™ offers broad form coverage that will protect you against most losses, and in most cases, provide the replacement cost for your property. Each claim is subject to a \$500 deductible. Every loss is individually evaluated. Typical covered losses include fire & flood, theft & burglary, windstorm & tornadoes, surface water & sewer backup.

**Q: Are all of my contents insured?**

A: All contents that you store in your unit are insured automatically with the exception of: jewelry, furs, currency, securities, automobiles, watercraft, trailers and accessories. There is also limited coverage on electronic equipment.

**Q: What Limits are available?**

A: The minimum limit available for purchase is \$2,500 and the maximum limit available on site is \$30,000. Higher limits may be available upon request.

\*Please note: Business property (defined as goods held for sale; business use tools and equipment; business documents and records) have a maximum limit of \$15,000 available.

**Q: What do I do in the event of a loss?**

A: Simply notify the Customer Service Manager of the circumstances as soon as they are discovered. If applicable, report burglary or theft of your stored property to the policy. Then contact Cowan Insurance Group at 1-866-912-6926 to report a claim.
